- 1. Objection to the inclusion / exclusion of the name in the provisional list may be submitted till 12.08.2023 i.e. the last date to file objections on the provisional list of PRAs,**
- 2. The eligibility of any person or any other person acting jointly or in concert with such person to be the Resolution Applicant ("RA") will be subject to fulfillment of conditions / criteria specified under section 29A of the IBC 2016 ("Code") at the stage of submissions of resolution plan.**
- 3. A PRA has to continue to be eligible under section 29A of the Code at the time of submission of the Resolution Plan as well.**
- 4. The RP may seek any clarification or additional information or document from the PRA under sub-regulation 9 of the Regulations 36A of the CIRP Regulations, 2016.**
